**1. To approve the minutes of meeting of IQAC meeting held on 18<sup>th</sup> May 2023.**

**2. To Approve Action Taken report of IQAC Meeting held on 18<sup>th</sup> May 2023**

**3. Submission of NIRF data by 30<sup>th</sup> January 2024 for the academic year 2022-2023**

Director IQAC appraised that the IQAC has submitted the NIRF data as per given date and will wait for the result or any query from the NIRF. Next academic year the University will go for the all over university level NIRF raking.

**1. Submission of AISHE data by 5<sup>th</sup> February 2024 for the academic year 2022-2023**

Director IQAC appraised that the IQAC has submitted the AISHE data on 20<sup>th</sup> March 2024 as per given extension period by AISHE. There was no query received from AISHE.

**2. Discussion on QS-I-Gauge University Ranking (Expiring on 14<sup>th</sup> March 2024)**

A meeting was held on 16-2-2024 regarding QS-I-Gauge with Management and the following points were discussed:

- QS-I-Gauge University Rating Audit was discussed in relation to previous QS I Band.
- It was appraised that SGTU is looking for Platinum this time as SGTU has excelled in various parameters related to research and innovation in previous years.
- It was emphasized by the team that without attaining Diamond in all individual criteria, Platinum is not awarded and SGTU must focus first on attaining Diamond in all criterions.
- After reviewing previous QS I gauze audit, it was emphasized to strengthen diversity and research to a large extent.
- It was appraised to review certain parameters of QS I Gauge rating as per the health University requirement (as SGTU is a health university- more than 65% of the courses are medical & Paramedical field).

**3. Discussion on NAAC AQAR-I (Cycle-2) data submission for the academic year 2022-2023**

In this regards, a meeting was held on 06<sup>th</sup> March 2024 for review of data readiness for AQAR-1 submission, academic year 2022-2023. The following action points were discussed:

- Central Coordinators to provide status updates on each criterion for AQAR-1 readiness.
- Finalized timeline for data review by central coordinators: March 19, 2024.
- IQAC Review Date set for March 26, 2024.
- Final submission on SGT IQAC – AQAR portal scheduled for March 30, 2024.

**4. Preparation on academic administrative audit (AAA) for the academic year 2023-2024**

The Director of IQAC informed us that the academic administrative audit will be conducted in October 2024. The Hon'ble Vice-Chancellor will provide the names of the auditors, after which the meeting will be scheduled.

**5. Data analysis of the last 6 years starting from 2017 onwards.**

In this regard, Mr. Kundu will notify us when the data collection platform is ready for data uploads. Once it is operational, the IQAC team will upload the data from the past six years and analyze it.
