**MEMORANDUM OF UNDERSTANDING BETWEEN
PANCHPARMESHWAR VIDYAPEETH AND SHREE GURU GOBIND
SINGH TRICENTENARY UNIVERSITY**

This Memorandum of Understanding (hereinafter referred to as "MOU") is entered into on this day of 5th March 2025, by and between Shri Guru Gobind Singh Tricentenary (SGT) University, Badli Road- Budhera, Gurugram, Haryana, India - 122505, Phone-18001025661, info@sgtuniversity.org through its Registrar and Panchparameshwar Vidyapeeth, MIG-2, Govindpur Prayagraj, 211004, Uttar Pradesh, India, Phone- 8400702128, 9670116222, <https://ppvidyapeeth.org> through its Founder, Dr. Chandrashekhar Pran.

University and Vidyapeeth may each be referred to as a "Party" and together the "Parties".

1. SCOPE OF COOPERATION

That both the above institutions agree that there will be mutual cooperation in Teaching, Training, Research collaboration, Project development work. The areas of cooperation may include, subject to mutual agreement, any desirable and feasible activity that would advance the objectives of each institution. This may include joint academic activities such as:

- I. Acting as a Study Centre for courses offered by SGT University.
- II. Designing new 'Certificate Courses', 'Diploma Courses', 'Training Programmes', 'Workshops', 'Seminars & Symposia' from time to time based on the requirement of the nation under Minor Courses, Skill Development Courses and Value-Added Courses to be run jointly under affiliation with SGT University, as per the 'New Education Policy-2020' and crediting the same to the National Credit Bank.

- III. Taking all necessary steps for Teaching, Training and Awareness about Constitution, Citizenship, Panchayat, Nagar Palika and Sensible Leadership Development as per the 'New Education Policy-2020'.
- IV. Reciprocal placement of students in paid internships and co-working, whenever feasible.

2. NON-EXCLUSIVITY

The Parties agree that a number of initiatives such as the above will be undertaken during the term of this MoU. However, neither Party is bound to agree on any of the activities nor is this MoU intended to prevent either Party from entering into similar agreements with other institutions.


3. DETAILS OF COURSES

The Parties agree to launch the following courses under the Faculty of Law (FOL) and Faculty of Commerce and Management (FCAM):

- I. Sensible Leadership Development, Credit-4, Theory (NEP-2020)
- II. Sensible Leadership Development, Credit-4, Practice Work (NEP-2020)
- III. Panchayat System: Local Self-Government, Credit-4, Theory (NEP-2020)
- IV. Panchayat System: Local Self-Government, Credit-4, Practice Work (NEP-2020)

4. AMENDMENT

This MoU shall be recognized as the basic document of the agreement executed between the two parties. Further agreements relating to any program shall provide details about the specific commitments made by each party and shall not be effective unless they are put in writing by duly authorized representatives of the parties. Any modification, amendment, or waiver of any provision of this MOU shall be effective if, but only if, in writing and signed in person or by a duly

authorized representative of each party against whom enforcement of such modification, amendment or waiver is sought.

5. TERM AND TERMINATION

Both institutions shall provide the necessary resources for the agreed activities. This MoU shall take effect from the date mentioned in the first line of this document and shall remain valid for five (5) years. Either party may withdraw from this MoU provided that written notice of withdrawal is given to the other party at least three (3) months prior to the desired date. This MoU may be renewed for a period of five (5) years upon mutual written consent of both parties before the expiry date of the MoU. Each institution shall have copies of this agreement.

6. GOVERNING LAW, JURISDICTION AND DISPUTE RESOLUTION:


This MOU shall be governed by and construed in accordance with the substantive Central and State laws of India. In the case of any dispute that may arise in future shall be resolved through mutual consultation and discussion. All efforts shall be made by both the parties to iron out the differences, if any, and in the event of not being able to resolve the tangle, the issue may be resolved through Arbitration by the sole arbitrator to be mutually appointed by the parties. The arbitration shall be conducted in accordance with the Arbitration and Conciliation Act of 1996 and the venue of the arbitration shall be in Gurugram, Haryana.

Any and all disputes, controversies and conflicts between or among the parties arising out of or relating with this agreement shall be subject to the jurisdiction of Gurugram.

7. INDEPENDENT PARTIES

The parties are independent of the one another. Nothing in this MOU shall be constructed to create a partnership, joint venture, agency, or employment relationship between the parties. Neither party is authorized or empowered to act as agent for the other for any purpose and shall not behalf of the other enter into

any contract, warranty, or representation as to any matter.

8. CONFIDENTIALITY

Neither party shall publicize this MOU and the annexes thereto, the provisions herein or related subject matter to any third party unless agreed to in writing by the other party. The parties agree that any proprietary business and/or technical information or material received orally or in writing and which is designated as "Confidential" or similar restrictive legend (hereinafter "Confidential Information") provided in connection with this MOU will be held and maintained in confidence, including this MOU and its annexes, and shall not be disclosed to any third party without the prior written consent of the disclosing party. The obligation upon the parties to protect the Confidential Information of the other under this MOU shall survive any expiration or termination of the relationship between the parties for any reason.

9. LIMITATION OF LIABILITY:


For the purposes of this MOU, it is understood and agreed that neither party shall be liable for any negligent or wrongful acts, either of commission or omission, chargeable to the other, unless such liability is imposed by law. This MOU shall not be construed as seeking to either enlarge or diminish any obligation or duty owed by one party to the other or to a third party.

10. INTELLECTUAL PROPERTY RIGHTS (IPR)

Both parties agree to respect each other's rights to intellectual property. Each Party shall retain all right, title, and interest in its works, creations, and inventions, including all intellectual property rights therein (collectively "IPR Rights"), and nothing herein is intended or shall be deemed to be a transfer, license, release or waiver of its IPR Rights.

Neither Party is authorized to use the name(s) and/or logo(s), registered trademarks, service marks, logos, insignia, or any other proprietary designation (collectively the "Marks") of the other Party or its products or services without the

other Party's prior written approval. While using the said Marks, the party which uses the said Marks shall comply at all times with the current version of the applicable mark and logo guidelines of the other party without any fail.

11. FINANCIAL LIABILITIES

In the case of financial liabilities arising under this Memorandum of Understanding (MOU), both parties agree to resolve such matters through mutual consultation. Any financial obligations shall be determined and settled only through a written agreement signed by both parties. Neither party shall be held unilaterally responsible for any financial liability unless expressly agreed upon in writing.
