Cooperation in Academic and Research Related Activities

Universitas Hindu Negeri I Gusti Bagus Sugriwa (UHN Sugriwa) is the first State Hindu University in Indonesia, located in Bangli, Bali, Indonesia, and is under the parasol of the Ministry of Religious Affairs of the Republic of Indonesia. The university was established based on Presidential Regulation No. 20 of 2020, with the aim of meeting the demands of scientific and technological development, integrating Hinduism with other fields of knowledge, and producing high-quality human resources

SGT University is a private University in Gurugram, Haryana, India. The University came into existence by the Haryana Private Universities (Amendment) Act No. 8 of 2013, making educational opportunities available to all segments of society under the parasol of Dashmesh Educational Charitable Trust, founded in 1999. The University offers a unique blend of theoretical & practical training & cutting-edge technology to students, making them technically well-rounded professionals.

Universitas Hindu Negeri I Gusti Bagus Sugriwa (UHN Sugriwa) and Shree Guru Gobind Singh Tricentenary (SGT) University affirm their mutual interest in the development of academic and research related activities, and their desire to cooperate to better achieve these goals. In doing so both, SGT University recognize each other's desire to build capacity and excellence in teaching, research and community services.

Upon reaching agreement on specific activities/projects, the parties shall document their understanding of the specific terms of each activity/project in a written agreement to be signed by both parties.

Under the terms of this agreement, we propose cooperation between UHN SUGRIWA and SGT University, particularly through cooperation to actualize the *tri dharma* UHN SUGRIWA and SGT University while UHN SUGRIWA and SGT University do not preclude either university from



initiating in future discussion concerning a broadening or extension of this agreement that may result in other financial arrangement required.

Each party's financial responsibilities and contributions will be determined on a case-by-case basis and outlined in separate written agreements, as necessary, for specific collaborative projects or activities under this MOU.

Both parties agree to maintain the confidentiality of any proprietary or sensitive information shared or material received orally or in writing and which is designated as "Confidential" or similar restrictive legend (hereinafter "Confidential Information") provided in connection with this MOU will be held and maintained in confidence, including this MOU and its annexes, and shall not be disclosed to any third party without the prior written consent of the disclosing party. Each Party agrees to protect the Confidential Information disclosed to it with the same degree of care as it would use to protect its own confidential information of like nature, but not less than a reasonable degree of care, and agrees not to disclose to any third party the fact that the Confidential Information has been provided to or received from the other Party or that discussions are taking place between the Parties. The obligation upon the parties to protect the Confidential Information of the other under this MOU shall survive any expiration or termination of the relationship between the parties for any reason.

This MOU may be amended only in writing and signed by both parties. Neither Party may assign any of its rights or delegate any of its duties under this MoU without the prior written consent of other Party.

In the event a dispute arises in connection with the validity, interpretation, implementation or alleged breach of this MOU, the parties shall attempt in the first instance to resolve such dispute through negotiation and in the event of a non-resolution the matter, the MOU shall stand terminated. However, both the Parties will meet any residual obligations in connection with the present MOU, notwithstanding its termination.

Each Party shall retain all right, title and interest in its works, creations and inventions, including all intellectual property rights therein (collectively "IPR Rights") and nothing herein is intended or shall be deemed to be a transfer, license, release or waiver of its IPR Rights

Each Party ("Defaulting Party") hereby undertakes and agrees to indemnify and keep and hold the other Party ("Non Defaulting Party") indemnified and harmless from and against all claims, proceedings, damages, losses, actions, costs and expenses arising as a consequence of or out of this Agreement or arising from any breach of terms and conditions of this Agreement including any third party claims for infringement of intellectual property rights.

Nothing contained in this agreement implies that an agency, partnership or joint venture between the universities has been set up, and it is understood that both UHN SUGRIWA and SGT



University will carry out activities under this MoU as independent institutions. Neither university shall have any right or authority to create any obligation or responsibility in the name of, or on behalf of, the other.

This MoU will be effective for 3 (three) years but may be terminated by either party upon written advance notification of not less than 6 (six) months. However, both the Parties will meet any residual obligations in connection with the present MOU.

This MoU is signed in identical copies by the authorized representative of each university, the two texts being equally valid. In the event of any divergence of interpretation between any of the texts, the English text shall prevail.

Hopefully, the MoU will pave the way for future collaboration between UHN SUGRIWA and SGT University and will be a benefit and blessing to all of us.
