


## MEMORANDUM OF UNDERSTANDING



Purpose and collaboration: The purpose of the MOU is to provide social structure development create legal, technical and medical awareness, empowering women and differently abled people, provide development activities for children and carrying out allied programs under 'Samajik Vikas, SGT Ka Prayas' project.
2. The Roles and responsibilities:
  - 2.1 Roles and responsibilities of SGT University
    - i. To support library centre & promote education endeavors
    - ii. Health care and awareness activities
    - iii. Legal awareness support
    - iv. To advocate & support social upliftment programs
    - v. Trainings for women empowerment through self help group (shg), asha workers, anganwadi workers etc.
    - vi. To support in organizing Cultural and sports events/competitions for different age groups
    - vii. To promote public & private welfare schemes
    - viii. To provide technical guidance
    - ix. To support the target population of Divyangjan
    - x. Seating arrangement for SGT Team visiting for time to time.

## 2.2 Roles and responsibilities Gram Panchayat

- i. Continuous moral support
  - ii. Active participation
  - iii. Proper care of the resources provided by SGT University
3. Terms and conditions: The MOU between SGT University and the Gram Panchayat, Makdola Village can be revoked by either party by giving 30 days prior notice, otherwise stand in good faith for a period of 1 year from the date of signing.
4. Independent Contractors: The status of the parties under this MOU shall be that of independent contractors. No party shall be authorized to waive any right, or assume or create any contract or obligation of any kind in the name of, or on behalf of, the other or to make any statement that it has the authority to do so. Nothing in this MOU shall be construed as establishing a partnership, joint venture, agency, employment or other similar relationship between the parties hereto.
5. Governing Law, Jurisdiction and Dispute Resolution: This MOU shall be governed by and construed in accordance with the substantive Central and State laws of India. Any and all disputes, controversies and conflicts between or among the parties arising out of or relating with this agreement shall be subject to the jurisdiction of Gurugram.
- In the event a dispute arises in connection with the validity, interpretation, implementation or alleged breach of this MOU, the parties shall attempt in the first instance to resolve such dispute through negotiation and in case no resolution is reached, this MOU shall be terminated
