



MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding is made on 4-10-2024 between Faculty of Indian Medical System, SGT University located at Village Budhera, District Gurugram and Gram Panchayat, Iqbalpur village located district Gurugram Haryana.

Faculty of Indian Medical System, SGT University and the Gram Panchayat, Iqbalpur village desire to enter into an agreement in which they will work together to achieve the various aims and objectives relating to the 'Samajik Vikas SGT ka Prayas' project.

And WHEREAS Faculty of Indian Medical System, SGT University and the Gram Panchayat, Iqbalpur village are desirous to enter an MOU between them, setting out the working arrangements that both have agreed to complete the ' Samajik Vikas SGT ka Prayas' project.

1. Purpose and collaboration: The purpose of this MOU is to establish a collaborative relationship to improve health and wellness through Ayurvedic care, education, and preventive practices in the village community.

2. Objectives

- To provide accessible and affordable Ayurvedic healthcare services to the village community.
- To conduct health awareness programs, wellness camps, and preventive screenings.
- To promote the use of traditional and natural health practices.
- To collaborate on research, training, and documentation related to public health and Ayurveda.
- To promote children health care in schools as well as in village.
- To make female aware about menarche, menstrual hygiene, menopause and Ante-natal care.
- To develop herbal garden in village schools and space provide by Gram Panchayat.
- To make village community aware about common home remedies and preventive aspect for health problems.
- To Promote public and private welfare schemes.
- To support library centre and promote education endeavours.
- To advocate and support social upliftment programs.

3. Roles and Responsibilities

A. Faculty of Indian Medical System Shall:

- I. Provide qualified Ayurvedic doctors and staff for regular visits or health camps in the village.
- II. Offer discounted or free consultation and treatment services, as agreed.
- III. Supply Ayurvedic medicines, remedies, and educational materials during camps.
- IV. Organize awareness programs on nutrition, lifestyle diseases, sanitation, and traditional medicine.

B. Village Panchayat Shall:

- I. Provide necessary support, space, and facilities for health camps or mobile clinic services.
- II. Mobilize village residents for participation in healthcare programs and initiatives.
- III. Assist with logistics, local promotion, and community engagement.
- IV. Coordinate with local authorities to ensure smooth operation and safety.

4. Duration and Termination: This MOU shall remain in effect for a period of 2 years, from the date of signing, unless terminated earlier by either party with 30 days' written notice.

5. Independent Contractors: the status of the parties under this MOU shall be that of independent contractors. No party shall be authorized to waive any right or assume or create any contract or obligation of any kind in the name of, or on behalf of, the other or to make any statement that it has the authority to do so. Nothing in this MOU shall be construed as establishing a partnership, joint venture, agency, employment or other similar relationship between the parties hereto.

6. Governing Law, Jurisdiction and dispute resolution: This MOU shall be governed by and construed in accordance with the substantive Central and State laws of India. Any and all disputes, controversies and conflicts between or among the parties arising out of or relating with this agreement shall be subject to the jurisdiction of Gurugram.

In the event a dispute arises in connection with the validity, interpretation, implementation or alleged breach of this MOU, the parties shall attempt in the first instance to resolve such dispute through negotiation and in case no resolution is reached, this MOU shall be terminated.

7. Financial Implication:

Terms and conditions for each program, visit or an assignment or such exchange, including those concerning financial implications will be worked out between both the parties in writing.

8. Limitation of Liability

Neither party shall be liable for any negligent or wrongful acts, either of commission or omission, chargeable to the other, unless such liability is imposed by law. This MoU shall not be construed as seeking to either enlarge or diminish any obligation or duty owed by one party to the other or to a third party.

9. Assignment

Neither Party shall assign this Agreement or its rights and obligation hereunder without the prior written consent of the other Party
