





MEMORANDUM OF UNDERSATANDING

This Agreement is made and entered in as of __ February 2025 (the "Effective Date") By and

between

Vira International Ltd & Its Associated Companies (hereinafter referred to as "VIRA"), located at Unit 6 Masters Court, Lyon Road, Harrow, London HA1 2BT United Kingdom (which expression shall, where the context so admits, be deemed to include its successors, executors and administrators)

AND

Shree Guru Gobind Singh Tricentenary University (hereinafter referred to as "SGT University"), Budhera, Gurugram, Haryana through its Authorized Representative the Registrar, SGT University (which expression shall, where the context so admits, be deemed to include its successors, executors and administrators)

VIRA and the SGT University shall thereafter, as the context may require, individually be referred to as a "Party" and collectively be referred to as the "Parties".

Whereas in consideration of the Mutual Covenants herein contained the Parties agree as follows:

PURPOSE & SCOPE:

- I. Establish mutually beneficial cooperation in the recruitment-process for Internships of the students at SGT UNIVERSITY.
- II. To provide a platform for the students at SGT UNIVERSITY, on which they may build the foundation of their careers by providing them with an entry point to the Hospitality Industry.

RESPONSIBILITIES of VIRA:

- I. VIRA will act as a foreign collaborative partner with SGT UNIVERSITY and provide end-to-end support with comprehensive one-stop-solution access to all eligible & interested students at SGT UNIVERSITY.
- II. It will facilitate the process of providing international internship opportunities to eligible students at SGT UNIVERSITY for periods of 6-Months & 1-Year.
- III. It will facilitate the process of providing international Internship opportunities to Final-Year students and/or fresh graduates.
- IV. VIRA will commit to assisting all our applicants with any further internship or placement opportunities that may arise.
- V. It should draw up an affordable & exclusive cost-package for these opportunities, for the students at SGT UNIVERSITY.

- VI. It shall liaise with host organizations, sponsors, channel partners, and associates for negotiations & selection processes of SGT UNIVERSITY candidates.
- VII. It will facilitate all documentation work for the candidates, including VISA processing.
- VIII. It will provide continuous field support for all students during their stay abroad.
- IX. It will develop a program to create awareness among students for various opportunities and conduct presentations & seminars at the SGT UNIVERSITY campus for prospective/interested students, as & when required.

RESPONSIBILITIES of SGT UNIVERSITY:

- I. SGT UNIVERSITY shall provide all necessary documentation support related to its students who register for the selection process of VIRA.
- II. It shall promote VIRA as its approved International Internship Partner and will encourage its students to apply for their International Internship process through VIRA as an exclusive collaboration.

TERM AND TERMINATION:

- I. This Agreement shall be in effect for the term and shall embark on the Effective Date for Internships and shall conclude in 3 years ("Initial Term").
- II. The parties may thereafter renew the term of this Agreement upon mutual written agreement.
- III. Either party may terminate this Agreement upon thirty (30) days written notice to the other party. Termination of the Agreement shall not affect the rights and interests of any person, who, at the time of such termination, has been accepted or is currently enrolled as a participant in any of the services offered through VIRA.
- IV. Dispute resolution "Disputes arising between the parties out of or in connection with this MOU shall as far as possible be settled amicably. If no resolution arrived between the parties, the MOU stands terminated. However, the termination does not affect any rights of parties which may have accrued prior to said termination."

This MOU entails a discount of USD \$300 (for 12 months applicants) applicable at the time of final payment after the placement/offer.

Refunds:

- 1. J1 Visa: In the unfortunate event of a visa refusal, it is important to note that certain expenses may be incurred. These expenses typically include the registration amount of \$320, visa application fee of \$185, SEVIS fee of \$220, sponsor charges of \$570. In total, the cumulative amount would be \$1295, encompassing all costs. While we strive for a successful visa application process, it is crucial to consider the possibility of visa refusal and the associated financial implications.
- 2. For Other Countries: Registration fees is nonrefundable in any case & in case of forged documents program cost is nonrefundable.

MISCELLANEOUS PROVISIONS

I. Force Majeure

Each party will be excused from the performance required of it under this Agreement for any period, and to the extent that such performance is prevented, hindered or delayed in whole or in part, by any circumstance beyond its reasonable control (each a "force majeure event"), including without limitation arty ad of God, war, civil disturbance, court order, sets or regulations of governmental bodies, labor disputes, any failure or loss of supply or market, failure of a third party's performance nonperformance by other party, failure, fluctuation of non-availability of electoral power heat, light, air conditioning or telecommunications equipment, or other equipment failure or any such non-performance will not be a default under this Agreement nor grounds for termination of this Agreement by either party.

II. Confidentiality clause

"Both Parties shall not, without the express written permission, disclose any confidential information to any third Party, person, entity, etc. in any manner, directly or indirectly. For the purpose of this MOU, "Confidential Information" shall mean any and all technical or nontechnical information or know-how relating to the business, services and/or products of the disclosing Party. Each party shall:

- i. Protect any Confidential Information provided by the other party with the same degree of care as it exercises for its own information of like nature and;
- ii. use Confidential Information for the sole purpose of fulfilling its obligations under this MoU; and
- iii. return all Confidential Information to the disclosing party promptly upon the expiration or termination of this MoU.

VIRA acknowledges, agrees and undertakes that it will be deemed to be the Data Fiduciary as per the provisions of Digital Personal Data Protection Act, 2023 (DPDP Act) for all the personal information/data furnished to or accessed by VIRA under

this MOU. VIRA further agrees and undertakes to ensure compliance with all the provisions applicable to data fiduciaries for processing the aforesaid personal information in accordance with DPDP Act. VIRA further agrees and undertakes that any such data will be kept secret and confidential and retained or processed in accordance with the applicable data protection legislation including but not limited to DPDP Act and must not be passed on to any other agency or individual other than any person authorised by SGTU."

III. Parties Bound

This Agreement shall be binding on to the benefit of the Parties and their respective heirs, executors, administrators, legal representatives, successors and assigns when permitted by this Agreement.

IV. Indemnification

"Both parties hereby agree, under this MOU, to indemnify and hold each other harmless. VIRA will indemnify, defend and hold harmless the SGT University and its officers, employees, agents, representatives and successors and assigns from all claims, damages, assessments, costs, losses and other expenses of any kind, including but not limited to reasonable attorneys' fees and court costs arising out of or resulting from any claim, demand, suit, action or other proceeding brought that arise out of or relate to any allegation of deficiency in services or performance of obligations of VIRA under this Agreement."

V. Legal Construction

In case any one or more of the provisions contained in this agreement shall for any reason be held to be Invalid, illegal, or unenforceable in any respect, that invalidity, Illegality or unenforceability shall not affect any other provision in this agreement, and it shall be construed as if the Invalid, illegal or unenforceable provision had never been contained in it.

VI. Prior Agreements Superseded

This Agreement constitutes the sole and only agreement of the Parties and supersedes any prior understandings or written or oral agreements between the Parties respecting the subject matter of this Agreement.

VII. Amendment

This Agreement may be amended by the mutual agreement of the Parties to it, in writing, to be attached to and Incorporated in this Agreement.

The Agreement shall be governed by and construed in accordance with the laws in force in India.
