MEMORANDUM OF UNDERSTANDING

Shri Guru Gobind Singh Tricentenary University (SGT University), is a private University in Gurugram, Haryana. The University came into existence by the Haryana Private Universities (Amendment) Act No. 8 of 2013. SGT University, Gurugram was established in 2013 under the aegis of Dashmesh Educational Charitable Trust. Since its inception, the Vision of the SGT University has been to be an institution of excellence in higher education that continually responds to changing social realities through the development and application of knowledge, towards creating a people-centered, ecologically sustainable and just society that promotes and protects dignity, equality, social justice and human rights for all.

Since 1986 Police Training for Deputy Superintendent of Police and Sub Inspectors in Madhya Pradesh was provided at Jawaharlal Lal Nehru Police Academy (JNPA) at Sagar (the Institute exists since 1906). Apart from JNPA, training facilities also exist at Rustomji Armed Police Training College (RAPTC) at Indore and at various Police Training Schools (PTC). The need was felt for a state of the art Academy to fulfill the needs of training as per the challenges faced during modern civilian policing. For these reasons, in a phased manner, The Madhya Pradesh Police Academy was established in a new campus near the State capital Bhopal. In the first phase (Infrastructure) the Academy initially came into being as a Integrated Police Training Centre. Thereafter on 10 June 2013 the Madhya Pradesh Police Academy (MPPA) Bhopal finally came into existence. The Main purpose of the Academy is to provide Basic training to trainee Police Officers of the Rank of Dy.S.Ps and Police Sub-Inspectors in a state of the art training environment.

Whereas, Training Branch of M.P. Police (PTC Indore, PTS's and other training institutes across the M.P. state) and Madhya Pradesh Police Academy (MPPA), Bhopal desire to establish academic collaboration with Institutions of excellence in Law and Social Sciences in the country and SGT University, Gurugram is one among such recognized institutions and seeks to promote the institutional collaborations through this Memorandum of Understanding (MoU).

SCOPE OF AGREEMENT

This Memorandum of Understanding is signed between SGT University, Gurugram as First Party and Training Branch of M.P. Police and Madhya Pradesh Police Academy (MPPA), Bhopal as Second Party for the purpose of Academic Collaboration that will encompass exchange of students and members of faculty between the two parties as well as other academic activities, research and publication. In addition to this, active efforts will be made to develop joint training and research programmes that will be pursued in a collaborative spirit. Some of the collaborative areas include the following:

I. TERMS AND CONDITIONS OF COOPERATION:

1. SGT UNIVERSITY, GURUGRAM and MP Police Training Branch Bhopal shall collaborate in mutually agreeable academic events, teaching, training and research, wherever feasible. Such collaboration will be based on mutually agreeable terms and conditions specifically agreed for each of the collaborative efforts;
2. SGT UNIVERSITY, GURUGRAM and MP Police Training Branch, Bhopal shall collaborate in joint research projects on (i) Action oriented research to provide evidence base analytical data and narratives to inspire and help fine tune their anti-human trafficking efforts of police for enhanced effectiveness and impact. (ii) Creation of knowledge to help police strategize their anti-human trafficking endeavours (iii) Collaborate in study and

research on various aspects of human trafficking to understand the domestic situation, with reference to cause and effect, dimensions beyond the conventional definition, the vulnerability and attempts to ameliorate it, the methods used by trafficker to sustain captivity and enhance efforts for prevention, protection and prosecution, and other issues.

3. The SGT UNIVERSITY, GURUGRAM, and the MP Police Training Branch, Bhopal, will collaborate to conduct research and try gap analysis in lawmaking, law enforcement, adjudication, and public expectations in order to influence policy and practise.

4. Through intellectual and resource-based cooperation on Law Enforcement, Legal Efficacy, and Criminal Justice Mechanisms, SGT UNIVERSITY, GURUGRAM and MP Police Training Branch, Bhopal will jointly cooperate on professional capacity building and training interventions.

5. SGT UNIVERSITY, GURUGRAM and MP Police Training Branch, Bhopal would collaborate on Research Projects and Action Research financed by various international and national agencies on mutually accepted terms.

6. SGT UNIVERSITY, GURUGRAM, in collaboration with the MP Police Training Branch in Bhopal, will establish a study focus on various areas of victimological Orientation in policing and other criminal justice institutions, as well as other aspects of legal services authorities.

7. The collaborative training programmes would also include collaboration to teach police officers to Mid-Career Training programmes.

8. Faculty and other authorities from each of these institutions will be invited to significant seminars, conferences, and teaching opportunities at the undergraduate, graduate, postgraduate, and doctoral levels. The financial ramifications will be determined on an individual basis.

II. AREAS OF COOPERATION:

This Memorandum expresses a mutual desire by SGT UNIVERSITY, GURUGRAM and MP Police Training Branch, Bhopal cooperates in building intellectual and research capacity and scholarship. Additional areas of co-operation may be added by written consent of the two parties. Both the parties will act in good faith to ensure that the objectives in this Memorandum are realized.

II. TERMS OF AGREEMENT

Progress in realizing the terms and conditions referred to herein will be reviewed periodically as mutually agreed and the memorandum may be amended at any time by mutual consent and in writing. The implementation and/or continuance of programmes or projects established pursuant to this MoU, prior to the effective date of termination shall not be affected by the termination of this MoU.

1. This memorandum shall come into force immediately upon its signature by the parties;
2. The validity of this Memorandum of Understanding is initially for a period of five years from the date of its execution and the same can be further extended on mutual agreement;
3. There shall be no financial liabilities on both the parties;
4. This Memorandum of Understanding can be terminated by either of the parties by giving advance notice of six months and without jeopardizing the coursework or registration of any of the students of either institution; and

5. School of Law, Rights and Constitutional Governance from the side of SGT University, Gurugram and the designated Officer/Office/Centre decided by the Special DG, Training from the side of MPPA, Bhopal shall be the nodal agency for implementation of this MoU.

IV. INTELLECTUAL PROPERTY AND CONFIDENTIALITY

1. In respect of each project and programme of co-operation, the parties shall negotiate and mutually agree in writing on their respective rights to intellectual property and commercial exploitation of the same (including without limitation, trademarks and service marks, copyrights, patents, designs and confidential information pertaining thereto); and
2. Neither party shall, at any time disclose to any third party any confidential information of the other party which is acquired in the course of activities under this Memorandum, a collaborative project or a programme, without the prior consent of the other party in writing.

The confidentiality obligations herein will not apply to information in the public domain; information in the possession of the receiving party prior to the disclosure of the information; information which is independently developed by the receiving party; information required to be released by law; and information which is rightfully received by the receiving party from third parties without any breach of confidentiality obligations.


V. NON BINDING NATURE OF MEMORANDUM

Nothing in this Memorandum shall be construed as creating any contract, partnership, agency or other legal relationship between the parties. This Memorandum is only a non-binding statement of intent to foster genuine and mutually beneficial collaboration.
