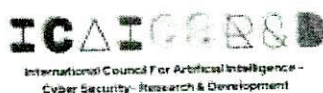

## 1. OBJECTIVE OF THE MOU

The objective of this Memorandum of Understanding ("MOU") is to promote Bilateral Cooperation between the Parties for mutual benefit, including International Council of Artificial Intelligence, Cyber Security, Research, and Development (ICAICSRD).

## 2. DURATION

## 4. RESOURCES AND RESPONSIBILITIES

### 4.1 ICAICSRD Responsibilities:

- a. Provide expertise and guidance in curriculum development.
- b. Facilitate faculty development programs and workshops.
- c. Assist in organizing research initiatives and conferences.
- d. Collaborate on the establishment and operation of legal clinics.

### 4.2 SGT University Responsibilities:

- a. Implement the agreed-upon curriculum changes with the approval of university authorities.
- b. Nominate faculty members for development programs and workshops.
- c. Provide necessary infrastructure and support for joint initiatives.
- d. Ensure the active participation of Faculty of Law, SGT University students in collaborative activities.

## 5. FINANCIAL ARRANGEMENTS

Each party's financial responsibilities and contributions will be determined on a case-by-case basis and outlined in separate written agreements, as necessary, for specific collaborative projects or activities under this MOU.

## 6. CONFIDENTIALITY

Both parties agree to maintain the confidentiality of any proprietary or sensitive information shared or material received orally or in writing and which is designated as "Confidential" or similar restrictive legend (hereinafter "Confidential Information") provided in connection with this MOU will be held and maintained in confidence, including this MOU and its annexes, and shall not be disclosed to any third party without the prior written consent of the disclosing party. The obligation upon the parties to protect the Confidential Information of the other under this MOU shall survive any expiration or termination of the relationship between the parties for any reason.

## 7. TERMINATION

Either party may terminate this MOU by providing written notice of termination to the other party with a minimum of thirty (30) days of notice. Termination of this MOU shall not affect any ongoing collaborative projects, which will continue as agreed upon in separate agreements or addenda.

## 8. AMENDMENTS

This MOU may be amended only in writing and signed by both parties.

## 9. GOVERNING LAW AND JURISDICTION

This MOU shall be governed by and construed in accordance with the substantive Central and State laws of India. Any and all disputes, controversies and conflicts between or among the parties arising out of or relating with this MOU shall be subject to the jurisdiction of Gurugram

For the purposes of this MOU encompassing specific programs between International Council of Artificial Intelligence, Cyber Security, Research and Development and SGT University it is understood and agreed that neither party shall be liable for any negligent or wrongful acts, either of commission or omission,
