



MEMORANDUM OF UNDERSTANDING

Memorandum of Understanding (herein referred as "MOU") is made and executed at Gurugram, on this 20-06-24.

BETWEEN

Shree Guru Gobind Singh Tricentenary University through its Department of Internal Quality Assurance Cell (IQAC), having its Campus at Budhera, Gurugram-Badli Road, Gurugram Haryana through its authorized representative Registrar, Shree Guru Gobind Singh Tricentenary University herein after referred to as "SGTU" (Which expression shall, unless repugnant to the context or meaning therefore, be administrators and/or assigns) of the **First Party.**

AND

Ramanujan College, University of Delhi located at Kalkaji, New Delhi - 110019, through its authorize representative Principal, Ramanujan College, University of Delhi (Which expression shall, unless repugnant to the context or meaning therefore, be administrators and/or assigns) of the **Second Party.**

The parties are individually referred to as "Party" and collectively referred as "Parties".

SHREE GURU GOBIND SINGH TRICENTENARY UNIVERSITY

Shree Guru Gobind Singh Tricentenary University is a leading educational institution based at Budhera, Gurugram-Badli Road, Gurugram, Haryana. The University has established itself as a high-quality education provider with prime focus on holistic learning and imbibing competitive abilities in students. The University is approved by UGC and prides itself in being the only multi-discipline campus in the Gurugram, spread over 65 acres and equipped with world class facilities. Ramanujan College is a authorized Malviya Mission Teachers Training Centre (MMTTC) from Ministry of Education to conduct FDP, and Faculty Induction Programme/ Orientation programs. Certificate of this program will make the participants eligible for Career Advancement Scheme of UGC & Ministry of Education.

1. SCOPE OF COOPERATION

The First Party and Second Party have mutually agreed to establish a dynamic teaching learning environment, augment professional capabilities and research-based knowledge and collaborative quality professional development programs.

The First Party, and The Second Party have agreed to the following terms and conditions in this present MOU: -

- I. The aim of the MOU is to enhance the capacity building of faculty members/ research Scholars by organizing online/ offline one-week/ two-week Faculty Induction / Orientation program, Faculty Development Programme (FDP) on various topics regarding Pedagogy, Research methodology and other related topics in Arts/ Commerce Management/ Behavioural Science/Science/Mathematical Sciences and Medical Sciences.
- II. All the parties have agreed that they will extend every form of co-operation to each other.

- III. However, the MOU can be extended to organize more such types of programmes in future.
- IV. All the parties will be responsible for organizing and managing the online training program as per the provisions mentioned above.
- V. Coordinators from the First Party will be Director IQAC and the Coordinator from the Second Party will be Principal Ramanujan College, University of Delhi, Delhi.
- VI. The MOU shall be made in two identical copies. All the versions are equally valid. Each of the parties of the MOU shall receive one copy of the MOU.

2. RESPONSIBILITY OF THE FIRST PARTY

The responsibilities of the "First Party" are given as under: -

- I.Administrative and logistic including support conveyance in terms of organising the program including stay, food etc. for outside faculties in case of residential program maximum upto 4 weeks.
- II.Publicity and Participation assurance for expertise, knowledge, and experience of the faculty members.
- III.Other academic facilities
- IV. Overall Cooperation.

3. RESPONSIBILITY OF THE SECOND PARTY.

The responsibilities of the "Second Party" are given as under: -

- i. Develop implement and maintain LMS portal tailored to the specific needs and requirements of the first party free of charge.
- ii. Organize faculty programme and facilitate content creation to ensure the portals effectiveness and relevance.
- iii. IT support and technical inputs required during the sessions and modules.
- iv. Registration fee will be collected by the Second party only.
- v. Brochure, E-Certificate and Flyer for publicity
- vi. Overall cooperation

4. FINANCIAL OBLIGATION

No financing obligations except the registration fee will be collected by Second Party which will be used to support portal, remuneration to resource person and organising team.

5. USE OF LOGO'S

The parties have mutually agreed and consented to the use of the First Party's name and logo (Shree Guru Gobind Singh Tricentenary University) on all program creatives, such as posters and brochures. They have also agreed to use the First Party's image on the creatives, as well as the name(s), affiliation, and contact information of the First Party's representatives (SGT University) who are members of the organizing committee and board. It is understood, agreed upon, and consented to be limited to this project within the specified time frame. In addition, the Second Party may not utilize the First Party's logo or any other creative mark or sign that is protected by intellectual property rights in any way. Any infringement of these rights will be considered as the breach of the confidentiality clause.

6. AMENDMENT

The parties through this present MOU have clearly agreed that the work plans and programs may be modified and supplemented by mutual consent of the Parties, and in view of this amendment/ modification and annexures, to this present MOU which forms an integral part of this MOU, has legal force which is subject to be done in written form and signed by authorized signatories of the Parties.

7. CONFIDENTIAL INFORMATION

The Parties will use reasonable efforts to cause its respective agents, employees, and representatives to minimize distribution and duplication and prevent unauthorized disclosure of the Confidential Information of the other party. Confidential Information" means any information, in any form or medium, that is confidential or proprietary to the disclosing party, including, but not limited to, technical, financial, commercial, business, legal, or other information that is designated as confidential or that should reasonably be understood to be confidential. Each Party shall maintain all of the other Party's confidential Information in strict confidence and in a secure environment and shall protect such information with the same degree of care that such Party exercises with its own confidential information. Except as provided in this MOU, no Party shall use or disclose any confidential information of the other

The obligation upon the parties to protect the Confidential Information of the other under this MOU shall survive any expiration or termination of the relationship between the parties for any reason.

If the Receiving Party is required to disclose the confidential information. in lieu of and as a part of a judicial process, government investigation. legal proceeding, or other similar process, the Receiving Party will give written notice of such requirement to the disclosing Party.

8. FORCE MAJEURE AND NATURAL CALAMITY

For the purposes of this MOU, force majeure shall mean and include an Act of God (including but not limited to flood, earthquake, typhoon, epidemic or other natural calamity) war or armed conflict or the serious threat of the same (including but not limited to prohibition or restriction of importation or exportation) or any other cause beyond the reasonable control of the Parties hereto including but not limited to industrial relation problem involving government/quasi government organization /banks/transportation / associations / others public bodies. In case of force majeure, the parties shall inform the other party about the liabilities to be carried out by them and are free from them after the receiving an MOU of force-majeure acceptance and it shall be base for the expiration of the corresponding part or as a whole of the MOU. Documents confirming the condition of force-majeure will be required for submission during the negotiation process, and Parties shall mutually consult each other to decide the course of action to be adopted.

9. TERM AND TERMINATION

This MoU shall come into force and take effect from the date first written above and shall be valid for a period of 3 (three) year and may be renewed thereafter by the parties upon mutual consent. This MOU may be terminated by either party by providing 30 (thirty) days written notice to the other party before the beginning of the academic year, and the termination would be effective at the end of the notice. However, obligations and commitments already contracted for and involving their parties shall be honoured and continued by both parties until such commitments are completed.

10. DISPUTE RESOLUTION, GOVERNING LAW AND JURISDICTION:

In the event a dispute arises in connection with the validity, interpretation, implementation or

alleged breach of this MOU, the parties shall attempt in the first instance to resolve such dispute

through negotiation and in the event of a non-resolution the matter, the MOU shall stand

terminated. However, both the Parties will meet any residual obligations in connection with

the present MOU, notwithstanding its termination.

The laws of Republic of India shall govern this MoU. Any and all disputes, controversies and

conflicts between or among the parties arising out of or relating with this agreement shall be

subject to the jurisdiction of Gurugram.

11. RELATIONSHIP

The status of the parties under this MOU shall be that of independent contractors. No party

shall be authorized to waive any right or assume or create any contract or obligation of any

kind in the name of, or on behalf of, the other or to make any statement that it has the authority

to do so. Nothing in this MOU shall be construed as establishing a partnership, joint venture,

agency, employment, or other similar relationship between the parties hereto.

12. LIMITATION OF LIABILITY

For the purposes of this MOU encompassing specific programs between the parties it is

understood and agreed that neither party shall be liable for any negligent of wrongful acts,

either of commission or omission, chargeable to the other, unless such liability is imposed by

law. This MoU shall not be construed as seeking to either enlarge or diminish any obligation

or duty owed by one party to the other or to a third party.
