Vision statement:

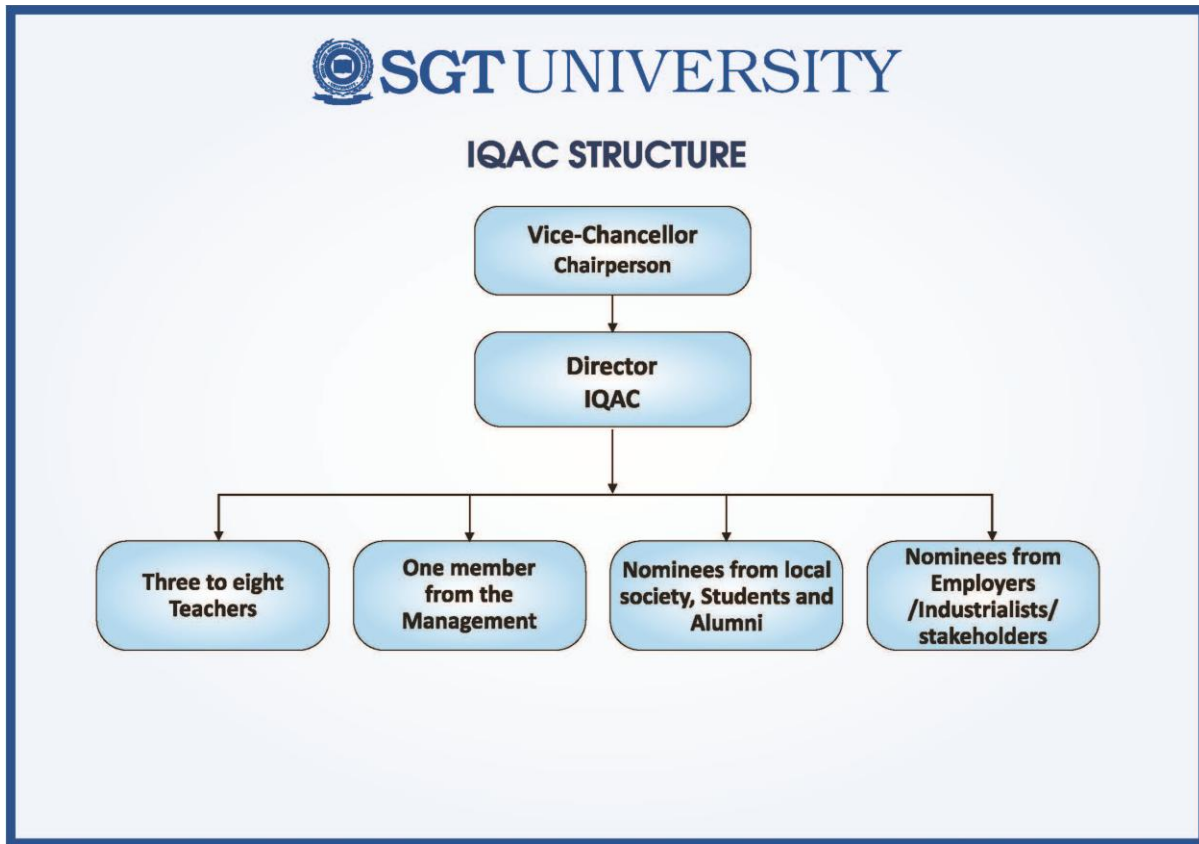
- To develop a system for conscious, consistent and catalytic action to improve the academic and administrative performance of the institution.





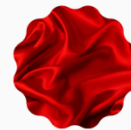

Report of the Event

a) Introduction of the Event:

Faculty of Law in association with Internal Quality Assurance Cell (IQAC), SGT University organized a Workshop on “Know Your Legal Rights: With Special reference to Constitutional and Criminal Law” by Prof. (Dr.) Sanjay Pandey, Dean of Faculty of Law, on the 29th of July 2022, at 11.00 a.m. The event witnessed an enormous participation from the faculty members from all departments of SGT University.

b) Objective of the Workshop:

The workshop is conducted to know about the Legal Rights – the concept and how it can be exercised in India. The aim of the event is to provide the faculty members a platform to enhance their knowledge related to the topic. The purpose is to give an acquaintance with some of the developments, problems and points of view in enforcing the legal rights with special reference to Constitution of India and criminal law in India. In addition, it is to encourage the faculty members to make a use of the knowledge and enforce their legal rights in India.

c) Brief report-

The Workshop was convened by Ms Rajasi Guharoy, Assistant Professor, Faculty of Law, SGT University. The expert explained the concept of legal rights. Further, the expert described certain unenumerated legal rights which are provided by Article 14, Article 19 and Article 21 of the Constitution of India. The expert also focused on certain legal rights which are laid down under the Code of Criminal Procedure 1973. The expert also enlightened the faculty members on how to enforce these rights with the help of various judgments of Supreme Court of India and High Courts. It was an enriching experience on the part of faculty members of SGT University.
